WSU Expectations and Guidance for AY2021-22 Undergraduate Program Assessment

This academic year, WSU recognizes that the COVID-19 pandemic context & impacts remain fluid and unpredictable, and that faculty, staff & students continue to manage concerns at work and home. Below are expectations and guidance for undergraduate program assessment this academic year, developed in discussion with the Provost's Office and the <u>Liaison Council for Undergraduate Assessment</u> (with representation from colleges and campuses offering undergraduate degrees).

For AY 2021-22, undergraduate degree programs are expected to:

- 1. Submit their 2021 program assessment report during the open reporting window anytime from mid-Dec 2021 through Feb 2022.
- Conduct some program-level assessment related activities, where possible, after taking into account program context and pressing questions.

WSU-wide Summary of 2020 Undergraduate Degree Program Assessment Reports Available

Over the summer, we review data from the undergraduate assessment reports submitted by programs and produce summaries for WSU, college, and campus leadership, as well as for our university-wide archives that provide evidence of assessment activities in support of university accreditation. In August, we provided Interim Vice Provost for Academic Engagement and Student Achievement Bill Davis with the 2020 WSU-wide Summary of Undergraduate Degree Program Assessment Reports. We extend appreciation to all faculty and chairs/directors who have invested time in program assessment activities, as well as into annual program assessment reporting, especially during a difficult year.

2020 WSU Examples of Use of Program Assessment to Inform Decision-Making

WSU undergraduate degree programs are responsible for regularly using assessment to support decision-making related to curriculum, instruction, assignments, and program assessment processes. Each year, we compile <u>selected examples of how WSU programs in various disciplines have used assessment</u> to inform decisions, as reported in the annual undergraduate degree program assessment reports. The examples, like the annual program reports themselves, look at key or representative activities and uses, and are not intended to be exhaustive or show all uses of assessment results by WSU programs.

WSU Program Assessment Case Studies Complimented by NWCCU Mid-Cycle Peer Evaluators

In April 2021, the remote accreditation evaluation team for WSU's NWCCU Mid-Cycle Evaluation visit met with a broad representation of institutional leaders. As part of the visit, peer evaluators met representatives from two selected program assessment case studies: The Department of Human Development and the University Common Requirements General Education Program (UCORE). The evaluators were impressed with the comprehensive, well-coordinated, and collaborative assessment infrastructure in place for these two programs.

	Mid Dec	Program assessment coordinators receive an email from ACE with a unique link to their <u>2021</u> <u>Undergraduate Program Assessment Reporting</u> form in Qualtrics. Assessment coordinators can submit their report during the open reporting window — anytime from mid-Dec 2021 through Feb 2022.
	21 st	Final grade submission ends.
Jan	7 th	Fall 2021 [CAPS] Assessment Reports for UCORE are due (i.e., reporting closes).
